for the 68th Annual Convention of

Instructions:

1. Ship fiber print cases or make arrangement to drop off at Marietta St. Onge's at 214 Newberry Road, South Windsor CT 06074.
2. Enter category letters.
3. Title each entry.
4. Sign certification.
5. Print out the return label and enclose the return shipping payment if you are not picking up your case at the convention.
6. Enclose \$65.00 for early entry (drop off prior to March 7th, 2017) or \$85 regular entry (between March 8th - March 14, 2017) in your **case** with the prints. Out of State case fee is \$125.00. No cases will be accepted after March 14, 2017
7. Enclose the entry form with the competition prints. It will be used as your judging tally. Recheck all the rules; non-compliance will prevent judging of your entry.
8. "Masters", "Out of area" entries and other "Special Category" exhibits will be judged by the same jurors and must use this form.
9. **A CD with low res JPG files of each of your images at 300dpi, 4" x 5" must be submitted with your entry or you may e-mail the images to print@ctppa.com**

No cases will be accepted after Tuesday March 14, 2017

Make sure to affix the completed, individual print entry forms to the top, center of each print entry. Please check print eligibility for the Reuben Schaller Award.

Note: The Sunset Award does not require use of Sunset Media, however, an additional prize is awarded if the winning image made use of Sunset Media in its printing.
